#### The First Minister of the Nunatsiavut Government is pleased to enact the following regulations:

#### **Short Title**

1.

These regulations may be cited as the *Inuit Community Government Election Forms Regulations*.

#### Interpretation

Terms used in these regulations and in the forms set out in Schedule A have the meanings assigned to them in the *Inuit Community Government Elections Act*.
