

EXECUTIVE ORDER TO AMEND THE NUNATSIAVUT GOVERNMENT TRANSITIONAL ORGANIZATION ORDER

Made Under the Authority of the *Nunatsiavut Government Organization (Transitional) Act*

The President of Nunatsiavut, acting with the advice of the Nunatsiavut Executive Council, is pleased to **ORDER** that:

This Executive Order is made under section 40 of the *Nunatsiavut Government Organization (Transitional) Act*.

Functions of Nunatsiavut Secretariat Amended

2

Section 5 of the *Nunatsiavut Government Transitional Organization Order* is amended by deleting clauses 5(g) and 5(h), renumbering clauses 5(i), and 5(j) as clauses 5(g), 5(h) and 5(i) respectively.

Presidential Portfolio Amended

3

Section 6 of the *Nunatsiavut Government Transitional Organization Order* is amended by inserting the word “and” at the end of clause 6(c), deleting clause 6(d) and renumbering clause 6(e) as 6(d).

Re-organization of Senior Management of the Nunatsiavut Secretariat

4

Section 7 of the *Nunatsiavut Government Transitional Organization Order* is amended by inserting the word and at the end of sub-clause 7(b)(v), deleting the words “interpreter and translation services” in clause 7(c), replacing the semi-colon at the end of clause 7(c) with a period and deleting clause 7(d).

Functions of Department of Nunatsiavut Affairs Amended

Functions of Department of Nunatsiavut Affairs Amended

Section 9 of the *Nunatsiavut Government Transitional Organization Order* is amended by deleting clause 9(f) and replacing it as follows:

- (f) establishing and administering housing policies, programs and services for the Nunatsiavut Government and the Inuit.

First Minister's Portfolio Amended

6

Section 10 of the *Nunatsiavut Government Transitional Organization Order* is amended by adding the word "and" at the end of clause 10(d) and deleting clause 10(e) and replacing it with the following:

- (e) housing for Inuit.

Re-organization of Senior Management of the Department of Nunatsiavut Affairs

7

Section 11 of the *Nunatsiavut Government Transitional Organization Order* is amended by inserting the words " who shall be responsible for all matters related to housing" immediately before the semi-colon in clause 11(a), inserting the word and at the end of clause 11(c), deleting clause 11(d) and renumbering clause 11(e) as 11(d).

Department of Health and Social Development Established

8

Part 4 of the *Nunatsiavut Government Transitional Organization Order* is deleted in its entirety and replaced with the following:

Part 4 Department of Health, Education and Social and Economic Development

16

There shall be a Department of the Nunatsiavut Government to be known as the Department of Health and Social Development.

Functions of Department of Health and Social Development

17

The Department of Health and Social Development shall have the following duties and perform the following functions:

- (a) establishing and administering health policies, programs and services for the Nunatsiavut Government;
- (b) establishing and administering social policies, programs and services for the Nunatsiavut Government; and
- (c) promoting the health and social well being of Inuit.

Portfolio of Minister of Health and Social Development

18

The Nunatsiavut Minister of Health and Social Development is the Minister responsible for:

- (a) Inuit health;
- (b) social services for Inuit; and
- (c) the well being and social development of Inuit.

Senior Management of the Department of Health and Social Development

19

The following shall constitute the senior management of the Department of Health and Social Development:

- (a) a Deputy Minister of Health; and
- (d) a Director of Social Development who shall be responsible to the Deputy Minister of Health for all matters related to the social policies, programs and services of the Nunatsiavut Government and the social well being and development of Inuit.

Department of Education and Economic Development Established

9

A new Part 6 is added immediately following Part 5 as follows:

Part 6 Department of Education and Economic Development

25

There shall be a Department of the Nunatsiavut Government to be known as the Department of Education and Economic Development.

Functions of Department of Education and Economic Development

26

The Department of Education and Economic Development shall have the following duties and perform the following functions:

- (a) establishing and administering economic development policies, programs and services for the Nunatsiavut Government and promoting the economic development of Nunatsiavut; and
- (b) establishing and administering educational policies, programs and services for the Nunatsiavut Government and promoting the education of Inuit.

Minister of Education and Economic Development

27

The Nunatsiavut Minister of Education and Economic Development is the Minister responsible for:

- (a) Inuit economic development including the Inuit Capital Strategy Trust and the Labrador Inuit Development Corporation; and
- (b) Inuit education.

Senior Management of the Department of Education and Economic Development

28

The following shall constitute the senior management of the Department of Education and Economic Development:

- (a) a Deputy Minister of Education and Economic Development; and
- (b) a Director of Inuit Education who shall be responsible to the Deputy Minister of Education and Economic Development for all matters related to the educational policies, programs and services of the Nunatsiavut Government and the education of Inuit.

Department of Culture, Recreation and Tourism Established

10

A new Part 7 is added immediately following the new Part 6 as follows:

Part 7 Department of Culture, Recreation and Tourism

29

There shall be a Department of the Nunatsiavut Government to be known as the Department of Culture, Recreation and Tourism.

Functions of Department of Culture, Recreation and Tourism

30

The Department of Culture, Recreation and Tourism shall have the following duties and perform the following functions:

- (a) administering the cultural and linguistic affairs of the Inuit and the Nunatsiavut Government, including policies programs and services for the preservation, use and development of Inuktitut and for the protection and management of archaeological and historic resources;
- (b) ensuring the supply of translation services for the public in relation to Nunatsiavut Government programs and services;
- (c) administering Nunatsiavut Government policies, programs and services for youth and elders;
- (d) administering Nunatsiavut Government policies, programs and services in relation to recreation; and
- (e) administering Nunatsiavut Government policies, programs and services in relation to tourism.

Minister of Culture, Recreation and Tourism

31

The Nunatsiavut Minister of Culture, Recreation and Tourism is the Minister responsible for:

- (a) protecting and developing the cultural heritage of the Inuit and fostering Inuit creativity through the arts;
- (b) providing Inuktitut translation and interpretation services on behalf of the Nunatsiavut Government for Inuit and the public;
- (c) promoting the well-being of Inuit youth and elders;
- (d) promoting active living and healthy lifestyles of all Inuit through recreation and sport; and
- (e) promoting tourism in relation to Nunatsiavut, strengthening Inuit participation in the tourism industry in Nunatsiavut and promoting economic growth and employment in the tourism industry in Nunatsiavut.

Senior Management of the Department of Culture, Recreation and Tourism

The following shall constitute the senior management of the Department of Culture, Recreation and Tourism:

- (a) a Deputy Minister of Culture, Recreation and Tourism;
- (b) a Director of Torngasok who shall be responsible to the Minister for all matters related to Inuit cultural affairs, language and historic resources, including translation services and archaeological permitting;
- (c) a Director to be known as the Director of Youth, Elders and Recreation who shall be responsible to the Minister for all programs and services related to youth, elders and recreation; and
- (d) a Director to be known as the Director of Tourism who shall be responsible to the Minister for all programs and services related to tourism and the development of tourism.

Old Part 6 Renumbered

11

The old heading “Part 6 Transitional Management Board” is renumbered as “Part 8 Transitional Management Board”.

The old section 26 is amended by renumbering the section as section 33 and deleting the period.

Miscellaneous and Consequential Amendments

13

The old section 26 is renumbered as section 34.

14

The old section 27 is renumbered as section 35 and the words “section 28” are deleted and replaced with the words “section 37”.

15

The old section 28 is renumbered as section 36.

16

The old section 29 is renumbered as section 37.
