Schedule

WHEREAS it appears from estimates of the Nunatsiavut Treasurer that the sums of money set out in the Schedule attached to this Act are required to defray certain expenses of the Nunatsiavut Government for the fiscal year ending March 31, 2009 and for other purposes relating to the Nunatsiavut Government;

AND WHEREAS it appears from the estimates that the Nunatsiavut Government will receive sufficient resource revenues under Part 7.5 of the Labrador Inuit Land Claims Agreement to pay the expenses set out in the schedule attached to this Act

NOW THEREFORE be it enacted by the Nunatsiavut Assembly as follows:

Interpretation

- 2. In this Act unless the context otherwise requires:
 - (a) "budget" means the Consolidated Financial Plan referred to in section 3 of the *Budget Act*, 2008;
 - (b) "Nunatsiavut Fund" means the consolidated revenue fund of the Nunatsiavut Government established and maintained in terms of Chapter 8 of the Labrador Inuit Constitution; and
 - (c) "supplementary budget" means the supplementary appropriation for the fiscal year ending March 31, 2009 under section 3 of this Act.

Supplementary Appropriation 2008-2009

3.

Appropriation

(1) In addition to the amounts set out in the *Budget Act, 2008*, IL 2008-01 the Nunatsiavut Treasurer may spend from and out of the Nunatsiavut Fund sums of money not exceeding \$ 12,252,622 in respect of the period from April 1, 2008 to March 31, 2009.

Authorized expenditures

(2) The sums of money appropriated under subsection (1) may be spent only for the purpose of defraying the expenses of the Nunatsiavut Government and for other purposes connected with the Nunatsiavut Government as set out in the Schedule and in accordance with the *Financial Administration Act*.

Consolidation of Budget and Supplementary Budget

(1) The supplementary budget shall be consolidated with and included in the budget.

Commencement

5. This Act is considered for all purposes to have come into force on April 1, 2008.
