WHEREAS the Nunatsiavut Assembly wishes to correct certain irregularities that have occurred in Presidential assents to the Subordinate Legislation enumerated on the Schedule and in the registration of certain Subordinate Legislation under the *Nunatsiavut Laws Registration Act*,

NOW THEREFORE BE IT ENACTED by the Nunatsiavut Assembly as follows:

Short title

1. This Act may be cited as the *Subordinate Legislation Rectification Act, 2009*.

Definitions

2. In this Act:

“Schedule” means the Schedule of Subordinate Legislation and effective dates annexed to this Act; and

"Subordinate Legislation" means a regulation, proclamation, rule, order, bylaw or instrument that is of a legislative nature and that is enacted in terms of an Act of the Nunatsiavut Assembly.

Effective date of Subordinate Legislation enumerated in the Schedule

3. The Subordinate Legislation enumerated in columns I and II of the Schedule is, for all purposes, considered to have come into effect on the date set out in column III of the Schedule notwithstanding any provision of the *Nunatsiavut Laws Registration Act* to the

contrary and notwithstanding any irregularity, error, omission or delay in the assent to or the registration of the Subordinate Legislation.

Subordinate Legislation enumerated in the Schedule has retrospective effect

4. The Subordinate Legislation enumerated in columns I and II of the Schedule shall be construed as having come into effect on the date set out in column III of the Schedule notwithstanding any presumption of law against the retrospective operation of legislation or subordinate legislation.
