

REGULATION RESPECTING OATHS OF OFFICE OF ANGAJUKAK AND COUNCILLOR
OF AN INUIT COMMUNITY GOVERNMENT

The First Minister of Nunatsiavut is pleased to enact the following regulations:

Short Title

1.

These regulations may be cited as the *Inuit Community Government Elected Officials Oaths of Office Regulations, 2006*.

Authority

2.

These regulations are made under subsection 141(3) of the *Nunatsiavut Elections Act*.

Interpretation

3.

Unless the context otherwise requires, terms used in these regulations have the same meaning as in the *Nunatsiavut Elections Act*.

Oath or Affirmation of Office of Angajukak

4.

For purposes of subsection 147(3) of the *Nunatsiavut Elections Act* the required oath or affirmation for the Angajukak of an Inuit Community is set out in Schedule A.

Oath Affirmation of Office of Councillor

5.

For purposes of subsection 147(4) of the *Nunatsiavut Elections Act* the required oath or affirmation for a Councillor of an Inuit Community Council is set out in Schedule B.

Schedule A

Oath or Affirmation for the Office of Angajukak

In full realization that the high calling I assume as Angajukak of the Inuit Community of _____ has been entrusted to me for the benefit of all residents of the Community, I, _____, swear [*in the case of an affirmation: "solemnly affirm"*] that I will be faithful to the residents of the Community and will obey, observe, uphold and maintain the Labrador Inuit Constitution, all laws and regulations of the Community and all other laws applicable within the Community; and I solemnly and sincerely promise to discharge my functions with all my wisdom, strength and talents to the best of my knowledge and ability, true to the dictates of my conscience and in accordance with my responsibilities as a leader. [*In the case of an oath: "So help me God."*]

Schedule B

Oath or Affirmation for the Office of Councillor in an Inuit Community Government

In full realization of the high calling I assume as a member of the Inuit Community Council of the Inuit Community of _____ and that the powers entrusted to me are for the benefit of all of the residents of the Community I, _____, swear [*in the case of an affirmation: "solemnly affirm"*] that I will be faithful to the residents and to the Community and will obey, respect and uphold the Labrador Inuit Constitution all laws and regulations of the Community and all other laws applicable within the Community; and I solemnly promise to fulfill my responsibilities as a leader and to perform my functions as a member of the Inuit Community Council to the best of my ability. [*In the case of an oath: "So help me God."*]
