Apply to the Nunatsiavut Energy Efficiency Retrofit (NEER) Program

2024 Commercial Application

The Nunatsiavut Government (NG) is introducing the Nunatsiavut Energy Efficiency Retrofit (NEER) Program. This program aims to reduce greenhouse gas emissions in the five (5) Nunatsiavut communities and improve energy efficiency and air quality on a community scale.

NG is accepting applications from registered Inuit-owned business owners interested in improving the energy efficiency of their enterprise. Approved applications will receive a **free energy audit** by a Certified Energy Auditor (CEA). These audits will follow ASHRAE Level 1 Guidelines which involves a trained professional evaluating your building's systems and highlighting inefficiencies and opportunities for improvement. After the audit is completed, the team will consult with you on what opportunities best suit your business. If your business is eligible and qualifies for this program, you could be entitled to **up to \$50,000** in Energy Efficiency Upgrades.

The program is available to <u>registered Inuit business owners</u> who are Beneficiaries in the Labrador Inuit Settlement Area. The facility must be a stand-alone building that is in operation for more than 6 months in a year, and reside in the Inuit Communities of Nain, Hopedale, Postville, Makkovik, and/or Rigolet.

Only the owner of the business can complete this application; if you do not own the business, you are not eligible to participate in this program at this time.

Applications for this program will be accepted from May 8 to July 10, 2024.
