# A GUIDE TO APPEALS TO THE INUIT MEMBERSHIP APPEAL BOARD

## Purpose

This guide provides a summary of the process for appealing from enrolment decisions of the Membership Committees and will help people who wish to appeal to the Inuit Membership Appeal Board.

## Other Guides

There are two other guides that may help you with your appeal:

- *Guide To Completing An Application To Be Enrolled as A Beneficiary of the Labrador Inuit Land Claims Agreement.* This is a detailed guide to completing the Application Form.
- *A Guide to the Enrolment Process under the Labrador Inuit Land Claims Agreement.* This is an overview of the processes and procedures followed in processing applications for enrolment, appeals and removals from the Register of Beneficiaries under the Labrador Inuit Land Claims Agreement.

## **APPEALS**

This guide gives a summary of the appeal process.

### **Right of Appeal**

If you have had your application rejected by a Membership Committee you have a right to appeal to the Inuit Membership Appeal Board.

### **Appeals to the Inuit Membership Appeal Board**

If a Membership Committee makes a final decision to reject your application it will give you written reasons for its rejection decision, remind you of your right to appeal its decision, and send you a copy of the form of Notice of Appeal.

The reminder of your right of appeal and enclosure of the form are done as a courtesy by the Committee. If the Committee does not give you a reminder or send you a copy of the form, you must get a copy for yourself and file your appeal within the 30 clear day time limit.

You must use the prescribed form if you decide to appeal a Membership Committee's final decision.

### **Time Limit**

You have 30 clear days from the day on which you receive the Membership Committee's decision to file your Notice of Appeal with the Registrar. Clear days mean that you do not count the day that you receive the decision and that your appeal must be filed no later than 31 days after that.

You must do everything you reasonably can to meet the deadline. If you intend to appeal, but cannot get everything done within the time limit, write to the Registrar and indicate that you are intending to appeal, and then get the Notice of Appeal filed as soon as possible. If you are late getting your Notice of Appeal filed, you will have to apply to the Appeal Board for an extension of time to file your appeal. Giving timely notice of your intention to appeal might help you to get an extension from the Appeal Board as long as you do not delay too long, and have good reason for your delay.

## Completing the Notice of Appeal

- Insert your application serial number.
- Identify yourself giving your full name and birth date and your address, phone and e-mail address.
- Identify the decision that you are appealing from.
- If you want notice of the date when the Appeal Board will deal with your appeal, put a mark in the “Yes” box. Otherwise, mark “No”.
- Say whether you want to appear in person at your appeal.
- If you have new, different, additional or better information that you want to rely on for your appeal, set out that information. If there is not enough space, attach any additional sheets or documents you may need. Note that when the Registrar receives your Notice of Appeal he or she will send your application form and any other information on your file to the Appeal Board.
- If you are going to have someone represent you at the appeal you must give their full contact details so that the Appeal Board can contact them.
- Date and sign the form.

If you have difficulties or questions about completing the Notice of Appeal, contact the Registrar’s office.

## Cost

You are responsible for paying your own costs of your appeal. In order to save costs you can ask to be heard by telephone conference call, but you must let the Appeal Board know that you want to be heard that way so that arrangements can be made.

## Procedures

If you wish to be heard at your appeal, the Appeal Board will consult you or your representative to settle on a convenient time. The Board will set up the arrangements and let you know about them.

**The Appeal Board has its own rules of procedure and will send you a copy.** You must follow these rules.

The appeal proceeds as a “re-hearing” of your application. In other words, it is not a hearing to review the Membership Committee’s decision or to decide if the Committee made any mistakes. Rather, it is a reconsideration of your application and all supporting information starting from the beginning.

On your appeal you have the right to supply new or additional information.

The Appeal Board will have copies of your application and any additional information that you may have given to the Membership Committee or the Registrar. The Board will make its decision on the basis of that information and any additional information you may present to it.

## Decision

The Appeal Board will send you its decision in writing. If the Board approves your application it will also inform the Registrar. The Registrar will enroll you as a **Beneficiary** and send you your **Beneficiary** card.

If the Appeal Board rejects your application they will give you its reasons.

## Review of Appeal Board decisions

The Appeal Board’s decision is final and cannot be appealed. But, if you believe it has treated you unfairly or that its decision is wrong, you have the right to ask the Federal Court of Canada to review the decision. If this is something that you plan on doing, you have 30 clear days to make your application to the court. You should seek the help of a lawyer.
