Apply to the Nunatsiavut Energy Efficiency Retrofit (NEER) program

2025 Residential Application

The Nunatsiavut Energy Efficiency Retrofit (NEER) Program is now accepting applications for homeowners interested in making energy efficiency improvements.

This program is available to *Beneficiaries* in the Labrador Inuit Settlement Area who meet the program requirements and reside in the Inuit Communities of Nain, Hopedale, Postville, Makkovik, and Rigolet. Only the homeowner can complete this application; if you do not own your home, you are not eligible for this program at this time.

The goal of this program is to reduce greenhouse gas emissions on a community-wide scale while also improving indoor air quality and home comfort for residents of Nunatsiavut. This can be done by upgrading existing building systems to reduce the amount of energy used and improving the insulation of homes. Eligible homeowners may qualify for **grants of up to \$20,000** (based on household income) to support home efficiency upgrades. This applies to homes with all types of heating systems.

Approved applicants will receive a **free home energy assessment**, conducted by trained professionals. This assessment will determine how much energy your home consumes and identify where improvements can be made. Based on the results, you may qualify for upgrades such as heating system upgrades, insulation upgrades, and other energy efficiency measures. **Please note:** Your Hydro Account Number is collected for program analysis purposes only and will not be used to determine eligibility.

Applications for this program will be accepted from **June 17th to August 11th, 2025**.
