



EXPRESSION OF INTEREST

Dental Hygienist Services

The **Non-Insured Health Benefits (NIHB) program** is a federal initiative that provides eligible Indigenous clients with coverage for a range of health benefits not covered through other social programs, private insurance plans, or provincial health insurance.

For Beneficiaries of the Labrador Inuit Land Claims Agreement (LILCA), the Nunatsiavut Government (NG) administers the NIHB program on behalf of Indigenous Services Canada. As part of our commitment to improving access to oral health services in the Nunatsiavut Region, NG is seeking expressions of interest from qualified Dental Hygienists, licensed in the province of Newfoundland and Labrador, to provide hygienist services to residents of the Labrador Inuit Settlement Area.

Scope of Services:

- Dental Hygienist to provide services in the 5 Nunatsiavut communities at least every 4-6 weeks during the term of Agreement.
 - Nain – ~ 6 trips/year, 18 days/trip, 8 patients seen a day
 - Hopedale - ~ 6 trips/year, 8 days/trip, 8 patients seen a day
 - Postville - ~ 6 trips/year, 3 days/trip, 8 patients seen a day
 - Makkovik - ~ 6 trips/year, 5 days/trip, 8 patients seen a day
 - Rigolet - ~ 6 trips/year, 4 days/trip, 8 patients seen a day
- Delivery of preventative oral health care, including cleanings, fluoride treatments, and oral health education.
- Collaboration with local health professionals and community health clinics.
- Documentation and reporting in accordance with NIHB and NG guidelines.

Qualifications:

- Registered Dental Hygienist in good standing in Newfoundland and Labrador.
- Experience working in Indigenous, remote and isolated communities is considered an asset.
- Strong communication and interpersonal skills.
- Ability to travel to communities throughout Nunatsiavut; Nain, Hopedale, Postville, Makkovik and Rigolet.
